The TAG Pathways to Leadership Certificate Program is a comprehensive 12-months leadership development initiative designed to empower emerging leaders with the skills, knowledge, and experience necessary to excel in their careers and communities. Through a combination of workshops, mentorship, and real-world projects, participants build their leadership capacity while driving meaningful impact.

- 79 Participants, over 5 cohorts, have successfully graduated.
- Each year, participants complete capstone projects in partnership with local nonprofit organizations, solving real-world challenges and delivering solutions that create lasting community impact.



#### **Program Delivery**

The program is delivered virtually with an on-site orientation retreat and program graduation.

#### **How to Apply**

Candidates are chosen based on their nomination by an executive within their organization, community, or P2L alumni. Interested individuals may also selfnominate.

#### **Program Fee**

\$5,500 per person with discounts available to TAG Corporate members, companies sending a team, and non-profit organizations. Payment plans are available upon request.
